

CURRICULUM VITAE

Hon. Mr. Justice Dr. Neville Camilleri

Dr. Neville Camilleri, son of Mr. Carmel Camilleri and Ms. Luigia Camilleri neé Attard, was born in Attard, Malta on the 28th. of March 1974.

After receiving his primary education at St. Francis School, Cospicua and his secondary education at The Archbishop's Seminary, Rabat, Dr. Camilleri pursued his studies at the Sixth Form in Msida and eventually at the University of Malta. In November 1996 and in November 1997, he obtained a Bachelor of Arts in Legal & Humanistic Studies and a Diploma of Notary Public respectively, both from the University of Malta. He graduated as Doctor of Laws from the same University in November 1999. His Doctor of Laws thesis focused on EC Competition Law bearing the title "The Rule of Reason under EC Competition Law". In December 1999, he was awarded a Diploma Course of Studies in Canonical Marriage Cases, Jurisprudence and Procedure organised under the auspices and direction of the Metropolitan Tribunal of Malta within the Archdiocese of Malta.

By November 2001, Dr. Camilleri pursued and obtained a Master of Arts in Financial Services with a thesis entitled: "The Inroads to the Doctrine of Separate Juridical Personality Under Maltese Law".

Since he was called to the Bar in March 2000, he practised extensively as a litigation lawyer in the Civil and Criminal Courts and in various tribunals, mainly in the field of civil, family, criminal and commercial law.

In November 2004, Dr. Camilleri was appointed as a member of the Refugee Appeals Board and in April 2005 he was appointed as Deputy Defender of the Bond in the Ecclesiastical Tribunal, which posts were held until he was appointed as a Magistrate of the Inferior Courts of Malta in April 2011.

Dr. Camilleri also served as an accredited arbiter in the Malta Arbitration Centre. Between 2004 and April 2011, he was entrusted by the main local insurance companies to act as arbitrator and acted extensively in a number of arbitration proceedings in Mandatory Arbitrations within the Malta Arbitration Centre and in Non-Mandatory Arbitrations.

Dr. Camilleri was entrusted to act as a mediator in litigious proceedings and was also requested to deliver lectures at the University of Malta within the Commercial Law Department, Faculty of Laws, University of Malta.

In April 2011, he was appointed as a Magistrate of the Inferior Courts and he took the oath of office as a Magistrate on the 28th. of April 2011. As a Magistrate, he had been assigned criminal cases, both in the Court of Magistrates (Malta) and in the Court of Magistrates (Gozo).

In April 2018, he was selected by his fellow Magistrates to represent them as a member of the Commission for the Administration of Justice in terms of the Constitution of Malta and continued to serve in this role until his appointment as a Judge of the Superior Courts of Malta in April 2021.

Following the first public call for the appointment of Judges of the Superior Courts in Malta in February 2021, Dr. Camilleri was approved and recommended by the Judicial Appointments Committee to be appointed as Judge of the Superior Courts and was eventually chosen by the President of the Republic of Malta Dr. George Vella to serve as a Judge of the Superior Courts. He took the oath of office as a Judge of the Superior Courts on the 22nd. of April 2021.

In April 2022, he was selected by the other Judges to represent them for a four-year term as a member of the Commission for the Administration of Justice in terms of the Constitution of Malta.

In April 2022, Dr. Camilleri was selected by the members of the Commission for the Administration of Justice to be

Malta's representative on the European Network of Councils for the Judiciary (ENCJ).

As a Judge, he had been assigned general civil law cases and constitutional first instance cases. He was solely assigned to the Civil Court (Asset Recovery Section) since it was set up in 2021 by the Proceeds of Crime Act (Chapter 621 of the Laws of Malta). Since January 2023 he has been assigned to the Criminal Court, hearing criminal appeals and trials by jury.

Dr. Camilleri has attended various seminars in Malta, co-ordinated by the Judicial Studies Committee regarding various topics, and other seminars abroad and has represented Malta's Judiciary in the European Network of Councils for the Judiciary (ENCJ).
